4. ~~(S//NF)~~ DURING DISCUSSIONS AT AN UNKNOWN DATE BETWEEN HAQQANI, SALAR, AND AN UNIDENTIFIED ISID OFFICER OR OFFICERS, HAQQANI AND SALAR WERE PROVIDED 200,000.00 USD TO ENABLE THE ATTACK ON CHAPMAN. HAQQANI PROVIDED THE MONEY TO SALAR WHO THEN COMMUNICATED THE PLANNING DETAILS TO MULLAWI ((SAKH)). SAKH THEN CONTACTED ((ARGHAWAN)), AFGHAN BORDER COMMANDER OF THE KHOWST PROVINCIAL FORCE. ARGHAWAN WAS PROMISED 100,000.00 USD BY SALAR FOR HIS ASSISTANCE TO ENABLE A SUICIDE MISSION BY AN UNNAMED JORDANIAN NATIONAL. FOLLOWING THE ATTACK, SALAR WAS BELIEVED TO HAVE KEPT THE 100,000.00 USD PROMISED TO ARGHAWAN BECAUSE ARGHAWAN DIED DURING THE SUICIDE ATTACK.
